### MAJOR SUBDIVISION SUBMITTAL CHECKLIST

#### A COMPLETED AND SIGNED CHECKLIST MUST BE SUBMITTED WITH APPLICATION

- APPLICATION FEE IS PAYABLE TO 'TOWN OF GHENT' AND IS NOT REFUNDABLE  
FEE IS COMPRISED OF A \$500 BASE RATE, **PLUS** \$75 PER LOT
- PROOF OR OWNERSHIP (COPY OF DEED OR LEASE), IF REQUESTED
- LETTER OF REPRESENTATION, IF APPLICABLE
- SIGNED AGREEMENT FOR PAYMENT OF EXPERT FEES [GPB-200-REV06.06], IF REQUESTED
- COPY OF ZONING USE PERMIT, IF APPLICABLE
- ORIGINAL, PLUS SEVEN (7) COPIES, OF THE COMPLETED APPLICATION FORM
- AN ORIGINAL, PLUS SEVEN (7) COPIES, OF THE STAMPED SURVEY MAP OF THE PROPERTY PREPARED BY A LICENSED SURVEYOR. MAP MUST INCLUDE
  - TITLE BLOCK INDICATING PROPERTY PARCEL NUMBER(S), NAME AND ADDRESS OF APPLICANT, AND LICENSED SURVEYOR
  - DATE, SCALE AND DIRECTIONAL ARROW
  - LOCATION MAP INSERT - A SMALL MAP SHOWING RELATION OF PARCEL(S) TO SURROUNDING AREA
  - CERTIFICATION TO THE TOWN OF GHENT PLANNING BOARD IN FURTHERANCE OF §156-31 – SEE DOCUMENT GPB-900-REV 11.06
  - ACCURATE BOUNDARIES OF THE PARCEL PLOTTED TO A SCALE OF 1 INCH: 40 FEET. THE SCALE MAY BE ALTERED IF THE PROJECT EXCEEDS A TOTAL LAND AREA OF FIVE (5) ACRES
  - THE LOCATION OF EXISTING AND PROPOSED BUILDINGS, PARKING AREAS, DRIVEWAYS, TRUCK-LOADING AREAS, WELLS AND SEPTIC SYSTEMS
  - ALL EXISTING WATER COURSES AND DEPARTMENT OF CONSERVATION-DESIGNATED WETLANDS, WITH INDICATION OF REQUIRED FLAGGING
  - ANY OTHER NOTES AS REQUESTED BY PLANNING BOARD
- AGRICULTURAL DATA STATEMENT [GPB100-REV06.06], IF APPLICABLE
- A 'LONG' OR A 'SHORT' STATE ENVIRONMENTAL QUALITY REVIEW (SEQR), COMPLETED AND SIGNED
- COMPLETION OF REFERRAL TO COLUMBIA COUNTY PLANNING BOARD – FORM GPB-1600
- THE NAMES AND MAILING ADDRESSES OF OWNERS OF ADJOINING/ADJACENT TAX PARCELS LOCATED WITHIN 500 FEET OF ALL PROPERTY BOUNDARIES
- PROOF OF APPROVAL FROM FEDERAL, STATE, COUNTY OR LOCAL AGENCIES, FOR ALL NECESSARY PERMITS. THE APPLICANT MUST DEMONSTRATE THAT **ALL** NECESSARY PERMITS HAVE BEEN SUBMITTED TO THE RESPECTIVE AGENCIES. THE PLANNING BOARD MAY, AT ITS DISCRETION, GRANT CONDITIONAL APPROVAL PENDING ISSUANCE OF REQUIRED PERMITS SUCH AS THOSE ISSUED BY
  - TOWN OF GHENT ZONING
  - NEW YORK STATE DEPARTMENT OF TRANSPORTATION, COLUMBIA COUNTY HIGHWAY DEPARTMENT AND/OR TOWN OF GHENT HIGHWAY SUPERVISOR
  - COLUMBIA COUNTY DEPARTMENT OF HEALTH

**SHOULD ANY PERMIT BE SUBSEQUENTLY DENIED, TOWN OF GHENT PLANNING BOARD APPROVAL IS AUTOMATICALLY NEGATED.**
